To date, the baby blanket has been completed and someone is finishing the afghan, which will be returned by the class to the couple. That, however, is not the end of this story.

Class members took some of this yarn home and, each week when they returned to class, they brought in their pretty little squares. Other members took these squares and worked their magic arranging the squares into a design; then others would stitch the squares together to make larger squares. By Christmas these ladies had quite a collection of lap throws completed. They called the couple who had donated the yarn in the first place, and told them what they had done and wanted to know where they would like the lap throws donated. Sadly, the elderly mother had passed away, but the couple requested that the throws be given to the facility where the elderly woman had stayed. They wanted them to be given to those who are not fortunate to have family and friends that are able to visit often, so that they would know that others were thinking of them and cared about them.

Who would have dreamed that one simple New Year's idea came to be reality, and that one gift profoundly touched the lives of all who laid hands on something so simple as a strand of yarn, and how that yarn wove its way into their hearts, knitting them all together in love!

R2I

Bridge to Independence (B2I) is a statewide program designed to assist individuals who reside in nursing homes and intermediate care facilities to transition back into their community. The goal of B2I is to allow flexible financing for state Medicaid programs with the objective that participants may choose to live in the most appropriate and preferred setting. The program is designed for older adults (65+)and persons with physical, mental, intellectual developmental, and disabilities. Individuals may qualify if they are Medicaid eligible and have lived in an intermediate care facility or nursing home for at least 90 days. Personalized transition services for B2I clients include extended pharmacy benefits, caregiver and peer supports, life skills training, safety planning, home and utility deposits, and other specialized services. These transition services are available to qualified individuals for 365 days after the date of discharge from a facility.

Golden Triangle Planning and Development District's Bridge to Independence program has successfully transitioned several participants out of nursing homes and intermediate care facilities. Those participants who have completed their 365 days of the program are now living independently in the community. The GTPDD Community Navigator works with each B2I client and a transition team to ensure that the client's needs are being met. The ability to know where every structure in the county is located has already made a difference in the lives of the residents of Winston County and has greatly enhanced the ability of the political officials to help the residents they represent. On April 28, 2014 a tornado struck Winston County causing much destruction and the devastating loss of ten (10) lives. The ARC grant received by the City of Louisville and Winston County facilitated a damage assessment of all structures and property. information was available for viewing by the elected officials, MEMA and FEMA at a speed never before seen in Mississippi. After the storm, the Golden Triangle Planning and Development District (GTPDD) GIS staff

was on-the-ground using information collected as a

result of the ARC grant. Employees were able to account for all missing structures, the parcel on which

they sat, the owners, the address and all information

needed to get residents affected into temporary


GTPDD staff was able to provide FEMA and MEMA geographic coordinates of all structures that were damaged with "before" and "after" pictures. Along with the photographs, MEMA was provided a list of every structure with tax parcel, damage estimates and a damage category already set up by MEMA. The four (4) categories used by MEMA were: Destroyed, Major, Minor and Affected.

each structure was evaluated. percentage of destruction could be added to the data. Damage assessment of cost, tax revenue lost and future county budgets were calculated within 48 hours after the storm had passed through the region. Map data generated by the PDD was used by the city and county to determine the best location for a debris disposal site. Maps of need assessment were easily created by utilizing previously collected data. From the State of Mississippi down, no one had ever seen anything like the location data that Winston County used for damage assessment and re-building.

The property is located on the north side of East Plymouth Road. The property has approximately 210 feet of frontage on East Plymouth Road. The rectangular site has an indicated depth of 325 feet, with frontage on the west side on Walnut Street and on the north side on Magnolia Street. The property

has an estimated area of approximately 1.57 acres.



The main structure is a steel-frame, corrugated metal building which rests on a concrete slab foundation. This building includes a total of approximately 6,655 square feet. The interior of this building is open work or warehouse type space with two small office areas. The office areas include approximately 792 square feet or approximately 12% of the total building area.

A second building is located just north, or to the rear, of the main building. This building is a corrugated metal structure on a concrete slab foundation. It measures approximately 40' X 60', or 2,400 square feet. This building has an eve height of 14 feet.



Other improvements include perimeter fencing, metal canopies at the rear of the main building, a large pole shed, and a combination of concrete and gravel paving.



Governor Phil Bryant recently announced that the Mississippi Development Authority (MDA) has approved FY2014 Appalachian Regional Commission (ARC) and Community Development Block Grant (CDBG) Public Facilities projects. Applications prepared by Golden Triangle Planning and Development District staff, which received funding, are:

MDA received 45 applications in the Regular Public Facilities competition requesting \$17,819,116 from an allocation of \$4,750,000. In the Small Government category, 77 applications were received, requesting \$29,531,686 from an allocation of \$6,956,071. City of West Point Awarded Mississippi Department of Archives and History Grant

The City of West Point has received an \$81,597 Community Heritage Preservation Grant (CHPG) from the Mississippi Department of Archives and History (MDAH) for exterior renovation of City Hall.

The Board of Trustees of MDAH awarded more than \$2 million on behalf of the CHPG program to



seventeen preservation and restoration projects across the state. This program, authorized and funded through Mississippi Legislature, helps preserve and restore courthouses, schools and other historic properties in Certified Local Government communities. Grant awards are paid on a reimbursable basis and require a twenty percent local match.

The intent of the proposed project is stabilization and preservation of the West Point City Hall which was designated as a Historic Landmark in 1985. The building, constructed in 1909, has served the citizens of this community for over 100 years. Time and exposure to the elements have taken a toll and created the need to address the deteriorating exterior conditions of this historical building. The clock tower, which has become an identifiable feature for the City, is also in need of immediate attention. The staff of Golden Triangle Planning and Development District will continue to work with the City's elected leaders throughout the implementation of this unique restoration project.

WIA (Workforce Investment Act) . . .

WIA Youth Program News:

The GTPDD Workforce Investment Act Program, Counseling to Career (C2C), is up and running in Choctaw, Oktibbeha, Webster and Winston counties! Beginning July 1, the WIA staff began the recruitment process for out-of-school youth, 21 years of age or younger, interested in developing workforce skills and practicing those skills at a local worksite where they would be paid through WIA funds. The C2C goal is that participants, upon completion of the program with the help of a C2C Counselor, will find full time employment or continue their education.

WIA staff report the participation of 48 youth at the end of December, 42 of whom have completed the required 21 hours of Work Ethics Training. These completers have been assigned to work sites; 6 non-completers have secured jobs on their own, using the skills taught in training.

Monies are available for 36 more motivated, energetic, dedicated-to-succeed youth to participate in this innovative program. Remember, they must be: 21 years of age or younger, not attending school and residing in Choctaw, Oktibbeha, Webster or Winston counties. (Clay, Lowndes and Noxubee youth may be served through EMCC.)

Business Recruitment News:

Approximately 50 businesses in Choctaw, Oktibbeha, Webster, and Winston counties partner with the WIA program to serve as worksites for C2C participants. The Golden Triangle WIA staff is continually looking for new businesses interested in supervising and mentoring youth during this work training process. There is no cost to the partnering business, as all salaries and workers comp insurance are paid through WIA funds.
