

WIOA GATEWAY PROGRAM

In 2024, we saw youth in Choctaw, Clay, Lowndes, Noxubee, Oktibbeha, Webster and Winston counties secure job training and temporary jobs, thanks to the WIOA Gateway In-School Workforce Training Program. After classroom instruction, youth are given an opportunity to train in selected jobs, proving to themselves and employers their capabilities as beneficial employees.

With salaries and workers' comp funded by the GTPDD, employers suffer no expense. Businesses may interview the youth applicants, so they have choices in whom they hire, supervise, train, mold and mentor. It is not unusual for businesses to retain youth trainees as permanent employees.

Often, when advised of this opportunity, a business owner or manager will respond, "What's the catch? This sounds too good to be true." The truth is: there is no catch, and there is no fine print. It is simply a win-win situation for youth and businesses. Youth get a chance to practice skills learned during training, and a business is given a free employee. There are many businesses in our seven-county area that work with the program year after year to train these young people for future workforce positions in their companies. To these businesses, we say thank you!

The program is available to high school students in Choctaw, Clay, Lowndes, Noxubee, Oktibbeha, Winston and Webster counties. Participants receive six hours of essential job skills training before being placed in a paid internship in their local community. Each participant has a career counselor who works with them to help them reach their career goal, whether that be continued education/training, employment or military enlistment. MUNICIPALITY & COUNTY WATER INFRASTRUCTURE

From the MCWI Grant Management Team:

Regarding the 12/31/24 ARPA/LFRF obligation deadline, the U.S. Treasury hosted a webinar that discussed in detail how to obligate your LFRF allocation by the 12/31/24 deadline and when to report that obligation into the U.S. Treasury reporting portal. They stressed that all LFRF funds allocated to local governments MUST be obligated by 12/31/24 without exception, including all lost revenue funds. As a reminder, lost revenue funds are not automatically considered to be obligated.

Reporting your obligation of LFRF funds used towards your MCWI match into the MCWI portal is not enough to satisfy your reporting obligations to U.S. Treasury. The MCWI portal is not managed by U.S. Treasury, thus you must also timely report all obligations and expenditures into the U.S. Treasury portal in accordance with the required reporting deadlines depending on what type of recipient you are as determined by Treasury. A few highlights from the webinar include:

- The focus for all local governments at this time should be obligating all LFRF funds by the 12/31/24 deadline. All obligations that occur between your last reporting period and the next reporting period will be able to be reported into the Treasury portal during your next reporting cycle. For example, if you executed a MOU to obligate your LFRF funds prior to 12/31/24 you can report that in during your next cycle, the execution date just must be on or before 12/31/24 and that MOU will need to be reported into and uploaded to the Treasury portal during the next cycle. If you have executed an MOU on or before 12/31/24 then the fund amount listed in that MOU would be considered to be obligated and you will just need to report it into the Treasury portal during your next reporting cycle.
- Next reporting periods for US Treasury:
 - January 1-31, 2025 for quarterly reporters; and
 - April 1-30, 2025 for annual reporters.
- Lost revenue funds are not automatically obligated. There are a series of slides demonstrating how to obligate these funds and properly report them into the Treasury portal.

MEDICAID WAIVER



To celebrate this joyous time of year, the GTPDD sponsors the provision of Christmas gifts to Medicaid Waiver clients. Warm clothes, blankets, toiletries, food and household items are among the gifts purchased and delivered to clients.

Many elderly people do not have family or friends to share the holiday with, so the Medicaid Waiver staff makes sure they are remembered. Happy Holidays to all of our wonderful clients!





HOME AND COMMUNITY-BASED ELDERLY AND DISABLED WAIVER PROGRAM

What is it?

The Medicaid Waiver Program provides home and communitybased services that assist Medicaid clients to remain in their homes and avoid institutionalization. Eligibility is determined through a comprehensive pre-admission screening instrument encompassing activities of daily living, sensory deficits, cognitive deficits, behaviors and medical conditions.

What are the qualifications?

- 1. Beneficiaries must be 21 years of age or older;
- 2. Medicaid eligible;
- 3. Require the same level of care as someone applying for admission to a nursing facility.

What services are offered under this waiver?

- **Case Management:** Everyone in the program is assigned to a local case management team. This team consists of a registered nurse and licensed social worker who visit the client on a monthy basis. They are responsible for managing and coordinating the services for each participant.
- **Personal Care Services (PCS):** These are supportive services provided in the home of the participant. They include assistance with light housekeeping, laundry, meal preparation, bathing, dressing, personal hygiene and activities of daily living.
- Adult Day Services: This is a structured program that focuses on the strengths and abilities of the participant. This service allows participants to contact connections with their community and/or use all of their retained skills. Depending on the specific facility, the following services are provided: supervision and/or assistance with ADLs, group activities, nutritious meals and medication monitoring.
- **Home Delivered Meals:** A well-balanced meal is delivered to the home of the person who is unable to leave their home without assistance and/or is unable to prepare their own meals.
- **Institutional Respite and/or In-Home Respite:** This is provided to participants on a short-term basis because of the absence of or need for relief for the primary care giver. This can be provided in the home or other licensed respite care centers.


