CONTINUING TO SERVE!!!

Golden Triangle Planning & Development has been awarded funding to continue the Gateway Workforce Training program for in-school youth in Choctaw, Clay, Lowndes, Noxubee, Oktibbeha, Webster, and Winston counties for the PY 21 program year! Career and Technology Center youth will be offered the opportunity to learn job-preparation skills, job-seeking skills, and job-performance skills as well as receive a paid internship. Seniors scheduled to graduate in May 2022 will receive

first opportunity for participation, but applications from all students will be considered. Applications for participation will be available in the Career Center Counselor's or Special Population

Coordinator's office in each center when school resumes.

The PY 20 program year ended June 30th and once again proved to be a big success. Eighty – three (83) students were accepted into the Gateway Program. Eightyone of those participants completed training and were offered a paid internship in their local communities where salary and workers comp insurance were paid through WIOA funds. Seventy – four (74) participants accepted the internship, six declined due to obtaining a job, and three opted not to work. Many of these students proved themselves in their internship sites and were offered full-time positions upon completion of paid WIOA hours. Others were not hired but were given excellent recommendations for other job application purposes.



In addition to a paid internship, participants were offered the WorkKeys assessment and opportunity to earn a Career Readiness Certificate (CRC) which is now being required by many places of employ-



ment as well as by community colleges in order to enroll for advanced training. The cost of the assessment was paid through WIOA funds and remediation was offered to participants desiring to work toward a higher level CRC. WIOA staff will continue to work with these youth for a minimum of twelve months as they seek employment or continue their education.

The Gateway Program has proved rewarding for the youth, as well as local businesses who took advantage of Gateway services. Participants are offered workforce training, a paid internship, and Career Readiness Certificate while the employer receives the opportunity to mold and train a potential future

employee at no cost to his/her business

Now, other Area Youth need YOUR help! If you know a youth who will be enrolled in a local career and technical program in the fall who would benefit from essential job skills training and desires employment, tell them about the Gateway Program. They too can learn skills for employment success, earn money for their future, and receive support and services to reach future goals.

Home and Community Based Elderly & Disabled Waiver Program

Through participation with the State of MS Division of Medicaid, GTPDD provides home and community-based services to individuals who are at risk or would require the level of care found in a nursing facility called the Elderly & Disabled Medicaid Waiver Program.

To qualify for this service, the following components are required:

- 1. Beneficiaries must be 21 years of age or older;
- 2. Medicaid eligible
- 3. Require the same level of care as someone applying for admission to a nursing facility.



Services under this program include: case management, personal care services, in-home respite and/or institutional respite services, adult day care, expanded home health visits, transitional care, and home-delivered meals. All costs for services are reimbursable to an approved provider and all services must be approved by the Division of Medicaid.

This program includes the following counties: Choctaw, Clay, Lowndes, Noxubee, Oktibbeha, Webster and Winston. A registered nurse and a licensed social worker visit the client on a monthly basis. The registered nurse and licensed social worker, working together as a professional team, must conduct the initial, then yearly assessment to assure that the client qualifies for the program.



Brooksville, Mississippi News

The Town of Brooksville is completing a street improvements program that was funded by the Mississippi Development Authority through the Small Municipality Limited Population County Grant Program. The project was able to overlay the Main Street of Brooksville and complete the loop around Post Office and Depot Streets to serve all of the main commercial areas of the Town. Mayor David Boswell commented that "this project was a long time coming and had been needed for many years". The SMLPC Grant was for \$150,000.00 and the Town of Brooksville matched this mount with \$15,000.00. The Golden Triangle Planning and Development District served as the Project Administrator and Calvert-Spradling Engineers of West Point, Mississippi was the project engineer. Falcon Contracting of Columbus, Mississippi was the contractor.

Farmers Market Nutrition Program

Seniors, 60 years of age and older, with certain income qualifications, are eligible to receive a one-time benefit in the form of vouchers from the Golden Triangle Area Agency on Aging to shop at authorized local farmers markets. The vouchers are used to buy fresh fruits and vegetables grown by local farmers.

The purpose of the project is to increase the consumption of fresh fruits and vegetable by senior adults and increase the awareness of farmers markets. When buying local produce, you are supporting the local economy and your local farmer.

Local authorized farmers markets are located in Columbus, Starkville and West Point. Program participants will be able to redeem vouchers at an authorized farmers market through November.
